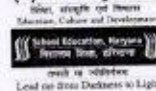

In exercise of powers conferred under Rule 29(3) read with Rule 3 of Haryana School Rules-2003 Education Department, Haryana hereby permit to add new proposed classes for higher stage. 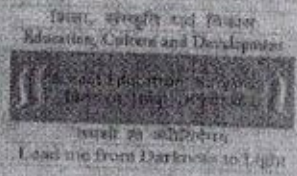
